## **Credit Card Information**

We do not view, collect, retain or otherwise have access to your credit card or bank details. Credit card details are processed via the National Australia Bank (NAB) which offer world-class, secure, third party payment gateways. These gateways employ the latest in encryption and security technology to keep your credit card details safe. When making a payment with us you will be transferred to the gateway's secure site before submitting your credit card details.

Security Information about the NAB Transact Internet Payment Service

At the GSDCV Inc. we offer the convenience of this secure real-time authorisation and payment service. The GSDCV Inc. website has been certified by the NAB to enable us to take credit card payments over the Internet. We currently accept payment from Visa and MasterCard credit cards.

NOTE: When you click the "Pay Now" button you will be dealing directly with the NAB to make the credit card payment. Your credit card details are **not** provided to the GSDCV Inc. by NAB. At the GSDCV Inc. we do not, at any time see, keep or store your credit card details. Your transaction with NAB is secured using the industry standard Secure Socket Layer (SSL) technology. Your credit card and personal details are encrypted when transmitted over the Internet.

Customers with browsers not supporting SSL 3.0 or above encryption technology (eg. browsers with versions lower than Internet Explorer 4.0 & Netscape 4.01) are not allowed access to payment facility, as transaction details cannot be securely transmitted.
